

DONATELIFE QUIZ NIGHT

Terms and Conditions

1. Registration and Attendance

1. Registration is free but essential to attend the Event.
2. All attendees must register prior to the Event.
3. Registrations are non-transferable unless approved by the Event organisers.
4. If you are unable to attend, please notify the organisers as soon as possible so your place may be offered to another participant.

2. Seating Arrangements

5. Attendees may register individually or as part of a group.
6. Individual attendees will be allocated to a table with an existing group.
7. Groups of six (6) people or fewer may be seated together with another group to create full quiz tables.
8. While organisers will make reasonable efforts to accommodate seating requests, table allocations are at the sole discretion of the Event organisers.

3. Event Participation

9. The Event is intended to raise awareness of organ and tissue donation and promote community engagement.
10. Attendees are expected to behave respectfully towards fellow participants, volunteers, venue staff and event organisers.
11. Organisers reserve the right to refuse entry or ask any attendee to leave if their behaviour is considered unsafe, disruptive, offensive or inappropriate.

4. Photography and Videography Consent

12. By registering for and attending the Event, you consent to the collection, recording, storage, use and disclosure of your image, voice and/or likeness in photographs, video recordings and other promotional materials captured during the Event.

13. You acknowledge and agree that such photographs, video recordings and other media may be used by DonateLife, SA Health and associated government agencies for promotional, educational, awareness-raising and communication purposes, including but not limited to websites, social media platforms, printed publications, media releases, advertising and other communication channels.
14. You acknowledge that any photographs, recordings or other media captured during the Event may be edited, reproduced, published and used at the discretion of DonateLife and/or SA Health.
15. You understand that participation in photography or videography is voluntary; however, attendance at the Event constitutes consent to incidental inclusion in Event photography and videography.
16. You release DonateLife, SA Health and associated organisers from any claims arising from the use of your image, voice or likeness in accordance with these Terms and Conditions.
17. Your image, voice and/or likeness may be retained and used for an ongoing or indefinite period unless consent is withdrawn in writing to the Event organisers.

5. Privacy

18. Personal information collected during registration will be used for the administration and delivery of the Event and in accordance with applicable privacy legislation.
19. Contact details will only be used for purposes related to the Event and DonateLife activities unless otherwise authorised by you.

6. Liability

20. Attendees participate in the Event at their own risk.
21. To the extent permitted by law, DonateLife, SA Health, event organisers, volunteers and venue partners are not liable for any loss, damage, injury or expense arising from attendance at the Event, except where liability cannot be excluded by law.
